Submissions must be made using the provided proposal form in the manner designated therein and enclosed in a sealed envelope bearing the name and address of the bidder and the contract description on the outside, addressed to Jennifer Rivera of the Pemberton Township Municipal Utilities Authority. Bidders are to comply with the requirements of P.L. 1975, C. 127 (N.J.A.C. 17:27), and the New Jersey Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.). The Instructions to Bidders, Form of Bid, Specifications, and other contract documents may be examined at the office of the Pemberton Township Municipal Utilities Authority, 131 Fort Dix Road, Pemberton, NJ 08068 and will be available for pick up by prospective bidders to take.

All bids shall be submitted only at the hours, date and place indicated above for receiving sealed bids. The Authority will reject submissions for this Contract where vendors are not properly qualified in accordance with the requirements of the specifications. The right is also reserved to reject any or all proposals or to waive any informalities where such informality is not detrimental to the best interest of the Pemberton Township Municipal Utilities Authority. The Authority shall have sixty (60) days within which to accept or reject bids. Submitted bidders shall be required to keep their bids open for that period of time and agree that they will not withdraw or reverse their prices therein.

Any addenda will be issued in compliance with New Jersey Local Public Contracts Law.
